The minimal balance on Swiss bank account shall be € 20,000 within first 3 months.

Personal visit to the banks in Switzerland will be required or alternatively for high net worth individuals personal banker visits to the client's place may be arranged.

Expected Requirements

The expected balance on private bank account shall be over €/USD 1,000,000.

That is the minimal amount required for private banker to visit personally the high net worth individual on his place of living.

Austrian Private Banking
